FUND UPDATE FOR THE QUARTER ENDING 31 March 2022

This Fund Update was first made publicly available on 3rd May 2022. It was amended on 13th December 2022 to include the following corrections: 1) the use of the DJIM US Total Return index instead of the DJIM US Price Return index, and 2) the Fund start date.



What is the purpose of this update?

This document tells you how the AE KiwiSaver Plan has performed and what fees were charged. This document will help you to compare the fund with other funds. Always-Ethical Limited (formerly known as Amanah Trust Management (NZ) Limited) prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

AE KiwiSaver Plan may only hold investments that comply with its Ethical Mandate. AE KiwiSaver Plan is approved to invest in AE Investor, an international equities fund and may also hold cash (New Zealand dollars).

AE KiwiSaver Plan's investment objective is to provide an ethical return to investors over the long-term, while strictly complying with the Ethical Mandate.

What are the risks of investing?

Risk indicator for AE KiwiSaver Plan -



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

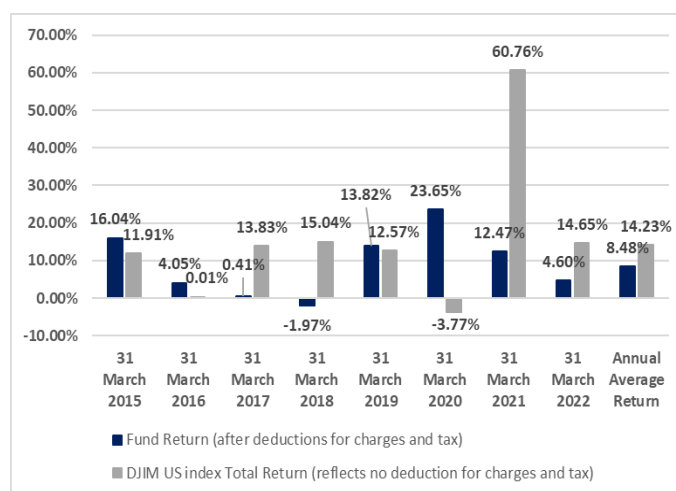
How has the fund performed?

Example of how this applies to an investor.

Imran had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the period, Imran made a gain after fund charges were deducted of \$436.00 (that is 4.36% of his initial \$10,000). Imran also paid \$32.40 in membership fees. This gives Imran a total gain after tax of \$403.60 for the year.

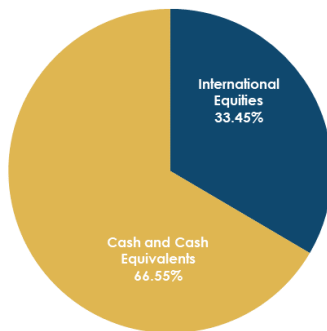
Small differences in fees and charges can have a big impact on your investment over the long term.

Notes

As required by the Financial Markets Conduct Regulations, the fund fees shown in this statement are based on the average month end net asset value of the fund. This is different to how the fund's fees are charged. The fund charges a management fee of 1.39% per annum and expenses which we calculated and accrued. A membership fee of \$2.70 per month (\$32.40 per annum) is also charged to each investor.

On the 30th September 2021, we changed our name to Always-Ethical Limited (formerly known as Amanah Trust Management (NZ) Limited) and AE KiwiSaver Limited (formerly known as AmanahNZ KiwiSaver Limited).

We also rebranded to AE KiwiSaver Plan (formerly known as Amanah KiwiSaver Plan), AE Growth Fund, (formerly known as Amanah Growth Fund) and AE Investor (formerly known as AmanahNZ).

We have deleted the reference to AE Growth Fund and replaced it with AE KiwiSaver Plan.
